I agree, individually and on behalf of Minor, to release and to hold harmless Willie George Ministries, Inc. d/b/a Church on the Move and Lincoln Christian School and their directors, officers, volunteers, and employees (collectively referred to as 'the Church and School') from any liability (including but not limited to liability for Minor's injury, death, or damage to or loss of Minor's personal property) resulting directly or indirectly from his/her participation in the Athletic Activity.
